

General terms and conditions of business

1. Range and validity

1.1. The general terms and conditions of BRANDING PARK business of (hereinafter named BRANDING PARK) shall apply for supplies that are conducted by BRANDING PARK to the customer. Obligations on behalf of BRANDING PARK refer solely to the range of products mentioned to the order received by BRANDING PARK or the respective order confirmation issued by BRANDING PARK and the stated "General terms and conditions of business" with respect to the goods of the order.

2. Prices and payment

2.1. Unless not subject to change in the order, all prices stated in the order shall apply. In addition the mandatory VAT shall be charged. On behalf of BRANDING PARK prices may be subject to change.

2.2. Payments shall be conducted after receiving the order confirmation from Branding Park.

2.3. In case of payment delay, BRANDING PARK reserves the right to cancel the order. This remains the fact until full payment has been received by BRANDING PARK.

3. Other regulations

3.1. Except when otherwise stated, Greek legal requirements between subjects representing registered companies shall apply. With respect to possible litigation and independent of the value to be litigated, the local jurisdiction of the commercial court in Athens, Greece, is considered established and agreed upon.

3.2. All notifications and declarations that are of concern to this contract shall only be valid when issued in written form and not contradicted by the recipient.

3.3. The employees of BRANDING PARK are obliged to comply with the GDPR Data Protection Law.

4. Additional regulations regarding the supply of goods

4.1. BRANDING PARK remains the owner of all goods supplied to the customer until such time payment has been received in full.

4.2. Except when otherwise stated, warranty period is six months.

4.3. Deficiencies that are subject to warranty will be repaired, respectively spare parts supplied, at the discretion of BRANDING PARK. It is agreed upon that product alterations or price devaluations are ruled out. Warranty shall be terminated in case repairs or alterations will be conducted by third parties.

5. Additional regulations regarding the rental of goods

5.1. The tenant shall be liable for damages, theft, loss of single components to the amount of value of a new product.

5.2. Rented goods that are returned with delay of time are subject to additional charge of the respective daily rental price according to the current price list, until the evident return of the good rented has taken place. The tenant shall accept the additional costs and is obliged to direct payment after the invoice has been received.

5.3. Extended reservation of proprietary rights shall apply to all goods of our rental park.

5.4. Delivery and collection of the goods remains BRANDING PARK's responsibility.

5.5. In case of malfunctions or deficiencies the tenant shall be obliged to contact BRANDING PARK and describe the encountered problems accordingly. Unauthorized placement of a repair order or maintenance shall not be acknowledged by BRANDING PARK. Further, cost compensation is ruled out.
